Research Midwives/ Nurses interested in joining The Reproductive Health and Childbirth National Research Champion (RHC-NRC) Group to represent Scotland

See Summary below and full remit attached:

The RHC-NRC group was established in December 2014. All Local Clinical Research Network's (LCRNs), via a recruitment process, selected a Senior RH&C Research Nurse/Midwife to become the Research Champion for their region.

One of the main aims is to be a community of practice consisting of Reproductive Health and Childbirth research active Nurses, Midwives & Allied Health Professionals representing all 15 LCRNs with associate members from the devolved nations of Wales, Scotland and Northern Ireland.

- Meetings will be quarterly.
- Each Champion will meet regularly with relevant members of their LCRN RH&C Leadership Team to communicate individual and group outputs.
- Each LCRN must be represented in a minimum of 3 face to face meetings per year.
- Champion Forum meetings will commence at 10.30 am and finish at 15.30 pm, venue will rotate between London and Leeds.
- All Champions are expected to actively contribute and participate in meetings.

The next meeting will be held on 10th January in Leeds, 10.00 for 10.30 am until 3.30 pm.

Chief Scientist Office joint funding call with Wellbeing of Women

Applicants can apply for up to £200k, the total amount available under this joint funding call is £400k. This call will cover laboratory, health and translational research in the field of women's reproductive or gynaecological health, to include problems in one of the following three areas: Pregnancy, Birth and the postpartum period; General wellbeing surrounding women's health issues; and Gynaecological cancers. Proposed work must be addressing a clinical or patient need and have clinical relevance within 5 years from the end of the project. We are particularly encouraging applications in one of the following priority themes:

- 1. Menopause
- 2. Studies using routinely collected data which are addressing any women's reproductive or gynaecological health theme e.g. using data to generate prediction models to personalise care
- 3. Urogynaecology, specifically looking at:
 - o Innovative methods for assessment of women with urinary incontinence
- □ Long-term outcomes for surgery for stress urinary incontinence (SUI) and pelvic organ prolapse (POP) For further details and how to apply please visit the Wellbeing of Women website.
