

#### Scotland Update

Since our last update, <u>November 2023</u> newsletter, the number of studies registered to the Associate PI scheme and number of applications in Scotland has increased.

In Scotland there are currently 6 RH&C Managed studies registered to the API Scheme which have Trainees On-Tenure or Completed the Scheme: LOCI, POISE, ESPriT2, REGAL, ROTATE and STOPPIT-3 (Data Cut 14/02/2024). 3 Applications Completed and 5 Tenure Active. See details <u>here</u>.

In addition, studies in the Scheme managed by other Specialties include Gynaecological Cancers managed by Cancer: BRITROC-2, PAIRS. Neonatal Studies managed by Children: FEED-1, SurfON. Together, 6 Applications Completed. See details <u>here</u>.
