A chance to shape future research

NHS Research Scotland and the NIHR Health technology Appraisal groups are looking to identify new research questions for future commissioned research calls. Our NRS Ageing group have been selected to submit their research priorities, and the focus is brain health. The plan is to submit around 10 possible research questions, often 1 or 2 are selected for a funding call. So, now I need your help. **If you have ideas for clinical trials in older adults, then please share them with me at the email address above.**

Update from Ageing National Speciality Group

There are big changes in clinical research infrastructure planned for 2024, with a new Department of Health and Social Care Research Delivery contract. While the most substantial changes will be seen South of the Border, these developments are still relevant to Scottish researchers. **The University of Leeds will host**



the NIHR Research Delivery Network Coordinating Centre (RDNCC) and will work with 12 Regional Research Delivery Networks across NHS England. What these changes will mean for researchers and research centres is still unclear, but given the attention generated by the Recovery, Resilience and Growth programme (aiming to get 80% trials recruiting to time and target) and the Lord O'Shaughnessy review (aiming to increase commercial trial activity in the UK) – these are likely to be a major focus of future activities.

Scottish researchers access to UK schemes

The Chief Scientist Office has worked with colleagues from across the UK to allow Scottish researchers to access more NIHR funding schemes. From Autumn, researchers based in Scotland will be able to apply to: Evidence Synthesis, Invention for Innovation (i4i), Research for Social Care (RfSC), Programme Grants for Applied Research programme (PGfAR), Programme

Development Grants. Now that we have this opportunity, we need to start submitting applications.

To keep the research 'pipeline' active we need to attract and retain the best people from early in their research career. The NIHR Associate Principal Investigator (API) scheme allows clinicians in training to work on studies under the supervision of a more experienced investigator. One of the conditions of the scheme inadvertently excluded Scottish only studies. Thankfully this is now resolved and applications for Scottish studies to the API scheme can be considered. <u>https://www.nihr.ac.uk/documents/associate-</u> pi-scheme-faqs/11698#studyteams

Entitled Health in an Ageing Society, Professor Chris Whitty recommends actions to improve quality of life for older adults and prioritise areas with the fastest growth in older people. I was pleased to contribute to the section on research in older people and highlight some of the challenges and opportunities in the field.

resource and is available to all working in the field of older adult research, not just members of the BGS. https://www.bgs.org.uk/research



Study looking for Scottish sites

The FORCE:SEE study (Frailty and Outcomes Record in Clinical Environments: probable Sarcopenia, geriatric Evaluation, and Events) is a product of the trainee led, Geriatric Medicine Research Collaborative. The study is observational and involves taking some simple measures of frailty in acutely admitted older people. The study now has approval to open sites in Scotland

and the anticipation is that most of the recruitment, follow-up, and management will be conducted by trainees. Obtaining research experience is now part of the Geriatric Medicine curriculum, so this really is an ideal opportunity to get involved in research.

Report on older adult research

A recent report from the Nuffield Council on Bioethics has highlighted that the needs of older people should be put at the heart of any research concerned with ageing. The report follows an inquiry by the Nuffield Council and makes for sombre reading. They note that research is being adversely affected by ageist attitudes in society, and raise concerns over the extent to which older people's values and perspectives are included in research planning, conduct and dissemination.

The report recommends that funders, regulators, ethics committees and journals all require "meaningful collaboration" with older people and that research projects "reflect the diversity of those likely to be affected, including those who are most disadvantaged."
